#### COVID-19 Survey of Passengers

This is a proposal based on the conversation between Cliff Chamber and Tyler Summersett on May 15, 2020 regarding a two-phase survey of Tuolumne County Transit (TCT) passengers on services provided during the COVID-19 shelter in plan and re-opening phases. It has been updated based on a subsequent phone call on June 24, 2020. The contract amendment will be an extension of the Short Range Transit Plan that AMMA Transit Planning is currently under contract to TCT to conduct. The large majority of the work will be conducted by subcontractor Mobility Planners LLC. It was generally agreed that this proposal provides a framework, but the implementation will require flexibility as the COVID-19 situation continues to evolve, and adaptation to new circumstances and restrictions may be necessary.

#### SUMMER 2020 DIAL-A-RIDE PASSENGER SURVEY CONDUCTED BY PROFESSIONAL STAFF

It was generally understood that the first phase survey would take place in the July to September time frame with a sample of passengers who have been using the general public dial-a-ride service. The sample plan and survey instrument will be developed and approved by TCT prior to proceeding. The cost proposal has options for a \$10 and \$20 gift card incentives for passengers completing the survey. This first phase survey will be a telephone survey. The logistics and methods for obtaining the telephone numbers from Storer will be part of the sampling plan development. The phone interviews will have a standard set of questions, with follow-up prompts based on the information provided by the passenger. The interviews would be conducted by Project Manager Cliff Chambers and Transit Planner Ronny Kraft. Mr. Chambers conducted the follow-up survey of passengers who completed September 2019 on-board survey. The base labor cost for phase one would be \$18,450 and is itemized below:

In addition, either a \$10 or \$20 gift card incentive is being proposed for successful completion of the survey and would add \$750 to \$1500 to the total costs. The \$20 gift card incentive was utilized in the original follow-up survey from the onboard survey last Fall, and it is the recommended incentive level.

The surveys would be tabulated and an administrative draft summary report on the key finding of the Summer 2020 passenger survey would be prepared. TCT comments will be incorporated a revised summary report.

# SUMMER 2020 DIAL-A-RIDE PASSENGER SURVEY CONDUCTED BY TEMPORARY WORKERS

This alternative would utilize all of the same methodology as above but would temporary workers to conduct the phone surveys. Temporary workers would be hired and trained to call dial-a-ride passengers. A survey instrument would be developed on Survey Monkey for the temporary workers to ask a standard set of yes/no and multiple choice questions. With temporary survey workers the base cost would be \$15,140 as itemized below.

As above the incentives at \$10 or \$20 gift card would add \$750 to \$1,500 to the total costs.

# EARLY 2021 PASSENGER SURVEY AND FOLLOW-UP CONDUCTED BY PROFESSIONAL STAFF

The early 2021 passenger survey is intended to be conducted after at least three months after Route 1 is re-implemented. The timing of this survey is not known. The survey for this round would be a mix of General Public Dial-A-Ride passengers and Route 1 fixed route passengers.

The onboard questionnaire will collect information similar to the September 2019 onboard survey of passengers, including the incentive offer. Follow-up phone surveys will be provided to Route 1 passengers who provide an email or phone number. There will be an attempt at completing 25 phone survey of Route 1 passengers. The questionnaires would be handed out to passengers by the drivers and returned to a manila envelope posted onboard the bus. Optionally, if social distancing rules are relaxed, then temporary surveyors could be hired and distribute and collect the completed questionnaires from passengers.

The second component of the Early 2021 passenger survey will be a telephone survey of approximately 50 dial-a-ride passengers. The sampling and implementation plan will be developed when it is decided to move forward with the survey. Both will be reviewed and approved by TCT staff before work proceeds. The base labor costs for conducting both survey components would be \$19,350 and is itemized below:

# EARLY 2021 PASSENGER SURVEY AND FOLLOW-UP CONDUCTED BY TEMPORARY SURVEYORS

This is the same alternative as above except that the survey interviews are conducted by temporary surveyors instead of by professional staff. The base labor cost for this alternative would be \$16,670.

#### TIME AND MATERIALS

If circumstances change, there may be a need to craft an additional scope of work for an alternative not described above. The labor rates would apply based on the other alternatives and other direct costs would be billed at cost.

In additional, gift cards of \$10 or \$20 would be provided for those completing the phone survey. This would add \$750 to \$1,500 per survey effort. If it is determined that drivers cannot collect surveys onboard Route 1, an additional \$3,450 would be required to hire and supervise onboard surveyors.
